G&A have employed independent Consultants, who provided a CarbonNeutral® company Greenhouse Gas (GHG) assessment report, prepared by Turley Sustainability, on behalf of Climate Impact Partners.

It relates to the operations of Griffiths & Armour, at their Liverpool, Manchester and Dublin Offices during the 1st December 2021 to 30th November 2022 assessment period.

Please note that the old Manchester office was operational during the whole reporting period, whilst the lease for the new Manchester office was signed on the 19th October 2022, therefore the assessment covers one month of the operation of the new Manchester office.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 170 tCO₂e by 2028. This is a reduction of 5%, based upon current Scope 3 included sources. We note that as the breadth of our Scope 3 data expands, the total output may increase. Our intention will be to reduce the increased output by the same percentage.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. We expect the carbon emission reduction achieved by these schemes equate to 11 tCO₂e, a 5%ge reduction against the 2022 baseline.

We recognise overall our Carbon Footprint is already very low bearing in mind our activities, number of employees (1.3 tCO₂e, compared to market norm which is circa 5 tCO₂e)

Current measures are

- Reduced number of face to face Client meetings (10% saving in transport equates to 4.7 tCO₂e)
- Reduced printing of Reports
- Reduction in home working

- Reduced business travel, in particular flights,
- Reduced use of Gas

We will be Carbon Neutral by August 2023 at which stage we will be working with our independent consultants to agree next steps which will include a carbon reduction plan.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
